1. PREFACE

Ensuring the sustainable development of the regions of Ukraine requires new approaches to the formation and implementation of regional strategies, substantiating the goals, tasks and principles of managing the sustainable development of the region, developing and applying new forms and methods of managing regional socio-economic systems. This problem is especially acute for Ukraine during the war and during the course towards integration into the European Union.

«Sustainable regional development of the EU» - this is an optional discipline, which is included in the catalog of optional disciplines for applicants of higher education of the second (master's degree) level for the educational and professional program «State Audit; forensic economic expertise in financial investigations», specialty 071 «Accounting and taxation» in order to popularize and implement the Jean Monet Module project Erasmus+ programs «EU Policy of Sustainable Development: Experience for Ukrainian Cities and Regions under the process of Decentralization» EUPSD — ERASMUS-JMO-2022-HEI-TCH-RSCH (Grant Agreement $N_{\rm P}$ — 101085764), which is implemented at the Faculty of Tax Affairs, Accounting and Auditing at the State Tax University.

The purpose of the educational discipline is to provide students with higher education with theoretical and practical knowledge about the regularities and peculiarities of the functioning of the EU regional economy, the current state and directions of sustainable regional development of the EU economy; about the peculiarities of the economy of the European Union as a holistic integration entity, studying the regularities of the interaction of regions within the EU in compliance with the goals of sustainable development.

Tasks of the academic discipline:

- definition and justification of the goals of sustainable regional development of the EU;
- analysis of the current state of sustainable regional development in the EU;
- study of models and ways of regional development in the EU;
- highlighting the regularities and features of the functioning of the regional economy of the EU;
- consideration of the main concepts and genesis of EU cohesion policy;
- justify the financial and economic independence of EU regions;
- to determine the social result of the economic development of EU regions;
- determine the essence of cross-border cooperation;
- study the European experience of decentralization reform.

Methods and forms of education: full-time (the form of education is the main form of obtaining a certain level of education with a break from production) and correspondence form (a form of obtaining higher education at each level of higher education without a break from production).

The main methods of teaching according to the nature of the presentation (presentation) of educational material: verbal (lectures, discussion, story), visual (demonstration of a presentation on the topic) and active methods of teaching in accordance with the specialization of research of the applicants (target audience). According to the organizational nature of education: methods of organization and implementation of educational and cognitive activities; methods of stimulating and motivating educational and cognitive activities; methods of control and self-control in education. Individual counseling work is an integral part of working out the topics of the academic discipline.

The individual task is aimed at a deeper study of the sustainable regional development of the EU. Individual work reflects the level of theoretical and practical abilities and skills of students, obtained during the study of this discipline, and the ability to apply them in real life.

Individual consulting work is planned in the format of writing an essay on the topic proposed by the lecturer or preparing abstracts of a report and presentation at scientific and practical conferences, forums.

Forms of organization of classes: lecture classes, practical classes, independent and individual consulting work, consideration and analysis of situational tasks, cases, application of information technologies and elements of distance learning in the system Moodle.

Criteria for evaluating individual work

Individual work for the day is done in the form of an essay or other forms described in the work program or methodical development and is evaluated from 0 to 5 points.

Individual work for extramural form is carried out in the form of an essay, presentation, projects or other forms described by the work program or methodical development and is evaluated from 0 to 10 points.

The final assessment of the knowledge of higher education applicants is carried out based on the results of current control (from 0 to 50 points) and differentiated assessment (from 0 to 50 points). The criterion for successful completion of the final assessment by the student is obtaining at least 25 points for the current control and 25 points for the final control in the form of a differentiated assessment.

The total distribution of points that a higher education applicant can receive within the 100-point evaluation system must include a mandatory computer test on the MOODLE distance learning platform of DPU (maximum 5 points).

The transfer of data from the 100-point rating scale into the national scale and the scale according to the ECTS system is carried out in the following order (Table 4.7):

The results of taking differentiated assessments are evaluated on a four-point scale («excellent», «good», «satisfactory», «unsatisfactory») and are entered into the student's record of success, the assessment book, the student's individual study plan (except for «unsatisfactory» and «failed»).
